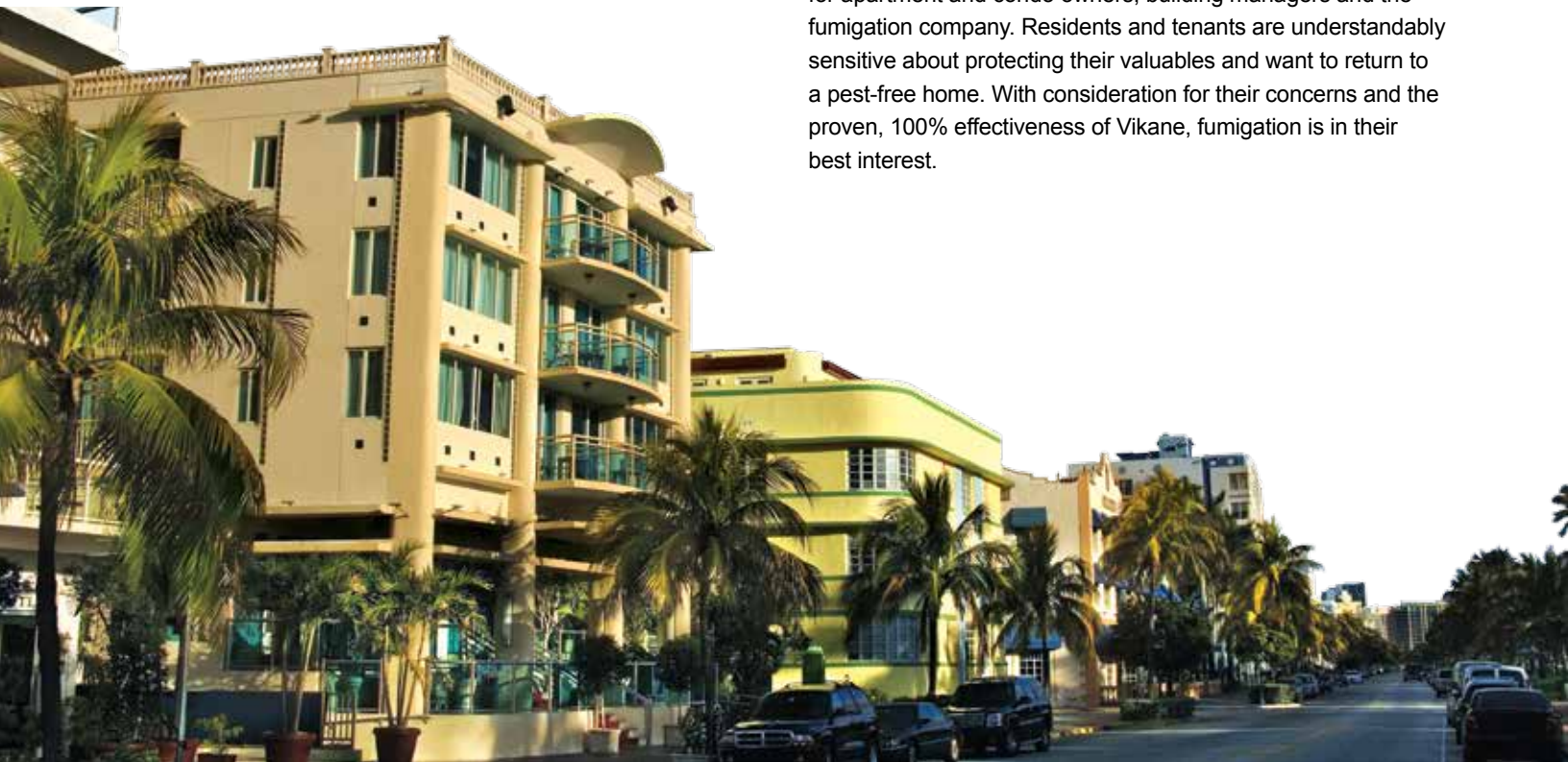

# Preparing a Building's Residents

Hold a meeting with all tenants well ahead of time — and send them updates regularly. Keeping people informed will help address any concerns and allow you to give them facts about fumigation. Some suggestions for information sharing include:

- Distribute a newsletter to tenants explaining the process.
- Post preparation and fumigation schedules, frequently asked questions and other helpful information on a one-page poster or flier throughout the building.
- Make sure residents know to visit **FumigationFacts.com** so they can learn about the process on their own time and in a pressure-free environment.

The fumigation company will provide residents with written instructions to help residents prepare, as well as clear guidelines as to what they will be responsible for. Have one resident from each unit or dwelling sign the form as written consent and a responsibility waiver for the fumigation company. Make sure you leave a copy with them for reference.

Provide the fumigator with contact information for maintenance staff, or ask them to be on-site during key parts of the process, so if there are questions or an emergency, your fumigator can help.

And address building security, which can include locks, signage, warning tape and even security guards to help prevent access during the fumigation and aeration phase.
